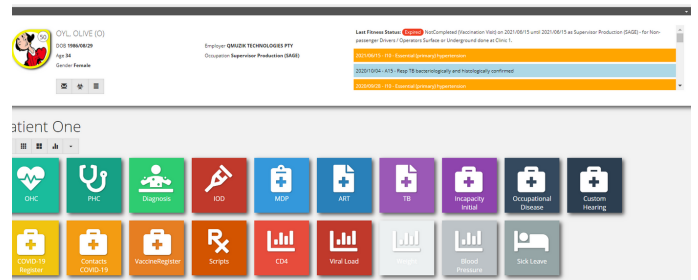

✓ PATIENT ONE VIEW

An online “one view” of all health related aspects of the patient is an available dashboard including OH Medicals, HIV screening, Primary Healthcare, Diagnosis, Acute Medicine, Sick leave and Managed charts

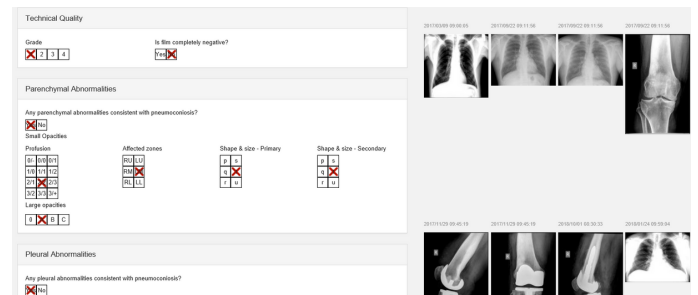


✓ MEDICAL EQUIPMENT INTERFACES

A key feature of Qmed is to interface the medical equipment directly with the Qmed system.

This benefits:

- Accuracy of information,
- Speed in recording results,
- Removes the opportunity to manipulate results when capturing,
- Supporting medical information (x-rays, vision, audio, spiro etc.) is directly available to the medical staff



✓ RISK BASED MEDICALS

Risk Based Medicals allow for Medical Surveillance to be based on Risk Exposures in the workplace. Occupational Hygiene data is incorporated with Occupational Health data to ensure actual risks and exposures are considered with medical surveillance. Where the patient has a risk profile (either occupation or exposure based), the risk profile will appear on the patient selection. Risks are represented in a colour code.

✓ INJURY ON DUTY INJURY ASSESSMENT AND REPORT

- IOD assessed on Qmed.
- Compensation can be recorded, linked to a specific incident and managed by case management.
- The TRISS (Trauma Score Injury Severity Score) is calculated automatically.



- NISS scoring performed with injury drill-down functionality.
- Reporting authority documentation (COID) such as hand, eye, and foot injury reports and first, progress and final medical reports can be generated.
